What You Need to Know:

Australia offers multiple visa pathways depending on your skills, family, and plans. Understanding which one suits you best is key to avoiding delays or rejections.

Popular Visa Pathways for UK Citizens:

- ➔ **Working Holiday Visa (subclass 417):** Perfect if you're under 35 and want to explore or try working in Australia for up to 3 years.
- ➔ **Skilled Migration (subclass 189/190):** For professionals with qualifications in demand in Australia.
- ➔ **Employer-Sponsored (subclass 482/186):** For those offered a role by an Australian business.
- ➔ **Partner Visa (subclass 820/801):** If your spouse or partner is an Australian citizen or permanent resident.



Expert Tips from Visa Executive:

- Don't assume your UK qualifications automatically transfer — check skill assessments early.
- Keep your visa paperwork clean and consistent. Even small errors can delay approvals by months.
- Plan your visa and relocation timelines together — they often overlap.

Quick Fact:

Around **38%** of permanent migration from the UK is **employer-sponsored** — so having a **job offer** can make a **big difference**.

Relocation Checklist:

Research your preferred state — housing laws, school systems, and job markets differ across regions.

- ✓ If you're renting, agents generally won't approve applications where **rent exceeds 30% of income**.
- ✓ Don't sign a lease **sight unseen** — get someone local to inspect on your behalf.
- ✓ **Plan early** if you're bringing **pets** — quarantine can take up to **9 months**.
